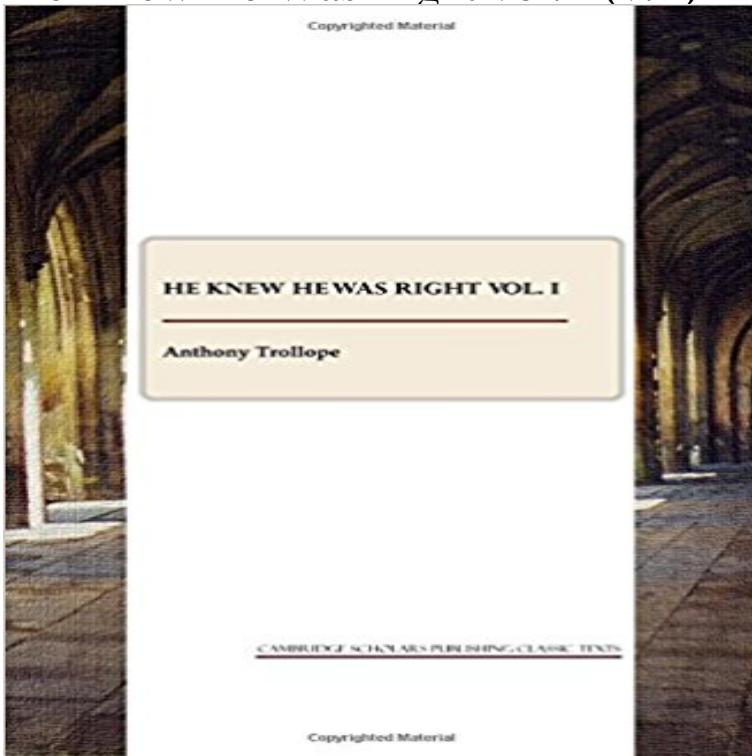


He Knew He Was Right vol. I (v. I)
